Institutional Characteristics Overview

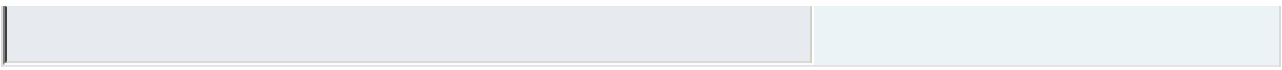
